THE PRIMARY CAUSE OF MALNUTRITION AND PERIODIC HUNGER CRISES IS THE LACK OF ACCESS TO FOOD. ACCESS TO FOOD IS LIMITED BY THE POOR'S INABILITY TO EITHER CULTIVATE OR BUY SUFFICIENT NUTRITIOUS FOOD TO MEET THEIR NUTRITIONAL NEEDS. ACCORDING TO USAID, APPROXIMATELY 60% OF THE INDIGENOUS POPULATION IN GUATEMALA IS MALNOURISHED. CHILDREN WHO BENEFIT FROM ONE NUTRITIOUS MEAL A DAY STAY IN SCHOOL LONGER THAN THOSE WHO DO NOT AND WHILE IN SCHOOL THEY ARE MORE FOCUSED AND MORE ATTENTIVE WHILE STUDYING.
